2 RESOLUTION DETERMINING THAT THE TRANSFER OF A TYPE 21 OFF-SALE
3 GENERAL ALCOHOLIC BEVERAGE CONTROL LICENSE FROM 3500 22ND STREET
4 TO 3699 17TH STREET TO ELLIE YANG LEE AND TERENCE SEH YANG FOR
5 SPIRIT PAPA'S MARKET WILL SERVE THE PUBLIC CONVENIENCE AND
6 NECESSITY OF THE PEOPLE OF THE CITY AND COUNTY OF SAN FRANCISCO,
7 IN ACCORDANCE WITH SECTION 23958.4 OF THE CALIFORNIA BUSINESS AND
8 PROFESSIONS CODE. WITH CONDITIONS.

10 WHEREAS, Ellie Yang Lee and Terence Seh Yang are seeking transfer of a
11 Type 21 off-sale general alcoholic beverage control license for Spirit Papa's Market
12 located at 3699 17th Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21
20 off-sale general alcoholic beverage control license from 3500 22nd Street to 3699 17th
21 Street for Ellie Yang Lee and Terence Seh Yang for Spirit Papa's Market, will serve the
22 public convenience and necessity of the people of the City and County of San
23 Francisco.

24 Conditions: 1) The hours of operation shall not exceed 7:00 a.m. to 10:00 p.m.
25 daily. 2) No wine shall be sold with an alcoholic content greater than 15% by volume.

1 3) No malt beverage shall be sold with an alcoholic content greater than 5.7% by
2 volume. 4) Wine shall not be sold in bottles or containers smaller than 750 ml., and
3 wine coolers shall not be sold in units of less than a four pack. 5) No pay telephone will
4 be maintained on the interior or exterior of the premises. 6) The applicant shall be
5 responsible for maintaining free of litter the area adjacent to the premises over which
6 they have control.




