2 ENACTING AND RESCINDING TRAFFIC REGULATIONS ON VARIOUS STREETS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
4 and the San Francisco Traffic Code, the following regulations governing the movement of
5 vehicles are hereby enacted or rescinded as designated below:

6 **DIAMOND (TRANSIT ONLY) LANE - ESTABLISH**

7 4th Street, west curb lane, between Market and Mission Streets (#4 southbound
8 traffic lane)

9 **STREET CLOSED TO VEHICULAR TRAFFIC, 10 AM - 3 PM, EVERYDAY (FOR TABLES
AND CHAIRS) - RESCIND**

10 **STREET CLOSED TO VEHICULAR TRAFFIC, 10 AM - 3 PM AND 5:30 PM - 10 PM,
EVERYDAY (FOR TABLES AND CHAIRS) - ESTABLISH**

11 Claude Lane, between Bush and Sutter Streets (change in hours of operation only)

12 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

13 26th Street, south side, from a point 60 feet east of Rhode Island Street to a point
14 60 feet west of Rhode Island Street (including curb area across from the
stem of this T-intersection)

15 **TOW-AWAY, NO STOPPING, BEFORE, DURING, AND AFTER BALLPARK EVENTS -
ESTABLISH**

16 Townsend Street, south side, from 325 feet to 420 feet west of 3rd Street (95-foot zone)

TOW-AWAY, NO STOPPING, BEFORE, DURING, AND AFTER BALLPARK EVENTS - ESTABLISH




