3 FRANCISCO TO ACCEPT AND EXPEND A GRANT IN THE AMOUNT OF \$468,640.00

13 for the purchase of technology equipment; now, therefore, be it



16 Francisco is authorized to execute on behalf of the Board of  
17 Supervisors of the City and County of San Francisco the attached  
18 Grant Award Agreement including and extensions, amendments thereof;

21 FURTHER RESOLVED, That it is agreed that any liability arising  
22 out of the performance of this Grant Award Agreement, including civil  
23 courts actions for damages, shall be the responsibility of the  
24 grantee and the authorizing agency. The State of California and the  
25 OCJP disclaim responsibility for such liability; and be it


1 FURTHER RESOLVED, That grant funds received hereunder shall not  
2 be used to supplant expenditures controlled by this body; and be it

4 FURTHER RESOLVED, That the Chief of Police of the City and  
5 County of San Francisco is authorized to accept and expend funds in  
6 the amount of FOUR HUNDRED SIXTY-EIGHT THOUSAND SIX HUNDRED FORTY  
7 DOLLARS (\$468,640.00), excluding indirect costs not allowed under  
8 this program, made available through the Office of Criminal Justice  
9 Planning for the project known as "CLETEP".


