2 ENACTING AND RESCINDING TRAFFIC REGULATIONS ON VARIOUS STREETS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
4 and the San Francisco Traffic Code, the following regulations governing the movement of
5 vehicles are hereby enacted or rescinded as designated below:

6 **BICYCLE LANES - ESTABLISH**

9 **NO RIGHT TURN - ESTABLISH**

11 **TOW-AWAY, NO STOPPING, AFTER BALLPARK EVENTS - ESTABLISH**

12 3rd Street, west side, from a point 370 feet south of 4th Street to a point 300 feet
13 north of 16th Street

14 **RIGHT LANE MUST TURN RIGHT - ESTABLISH**


