1 [AIRPORT CONCESSION LEASE]
2 APPROVING DOMESTIC BANKING SERVICES LEASE IN THE NORTH,CENTRAL AND
3 SOUTH TERMINAL BUILDINGS BETWEEN BANK OF AMERICA, NATIONAL
4 ASSOCIATION AND THE CITY AND COUNTY OF SAN FRANCISCO, ACTING BY AND
5 THROUGH ITS AIRPORT COMMISSION.

6 WHEREAS, The Airport Commission requested bids for the Domestic Banking
7 Services Lease in the North, Central and South Terminal Buildings; and,

8 WHEREAS, Bank of America, National Association submitted a bid of \$261,000, as the
9 minimum annual rent for the first year of the Lease; and

10 WHEREAS, Airport Commission staff determined that Bank of America, National
11 Association is the highest responsive bidder; and

12 WHEREAS, The Airport Commission awarded the Domestic Banking Services Lease in
13 the North, Central and South Terminal Buildings to Bank of America, National Association on
14 February 22, 2000; and,

15 WHEREAS, The Airport Commission and Bank of America, National Association have
16 agreed to amend the Lease to stipulate that if a court of competent jurisdiction deems
17 Proposition F to be applicable to the operations provided for in the Lease, Bank of America,
18 National Association will abide by the provisions of Proposition F or cease its ATM operations
19 at the Airport; now, therefore, be it

20 RESOLVED, That the Board of Supervisors hereby approves the Domestic Banking
21 Services Lease in the North, Central and South Terminal Buildings, copies of which are
22 contained in the Board of Supervisors' file number 000840.


