2 COMMENDING JOAQUIN SANTOS FOR HIS COURAGEOUS ACT OF SAVING A
3 DROWNING MANY FROM DEATH

5 WHEREAS, On May 18, San Francisco Deputy Police Chief Joaquin
6 Santos saved the life of a man whose truck had overturned in a water-
7 filled ditch on Highway 101; and,

8 WHEREAS, Deputy Police Chief Joaquin Santos was on his way get
9 his head shaved as part of the Police Department's campaign to raise
10 money for children with cancer and to clean out his office at the
11 Police Department after he had been health-related disability pending
12 retirement in two months; and,

13 WHEREAS, At 1 PM, 71-year-old Janet McGarry lost control of her
14 Toyota Camry and caused Timothy Ullon's car to slam into her Camry
15 and to end up upside down in a watery ditch; and,

16 WHEREAS, Deputy Police Chief Santos climbed out of his car,
17 waded into the water, pulled the door open and extricated the
18 drowning driver from his car; and

19 WHEREAS, After saving Ullon's life, Deputy Police Chief Santos
20 gave a brief report and his card to the California Highway Patrolman
21 and continued on his way to the Hall of Justice: and

22 WHEREAS, Later that day Deputy Police Chief Santos got his grey
23 hair removed with an electric razor as part of "Buzz the Fuzz", the
24 fund raiser for children's cancer; therefore be it

3 years of service to the San Francisco Police Department; and there be
