12 WHEREAS, Bullet dedicated her life as a counselor and a social worker and worked mainly  
13 with Asian and Filipino at-risk-youths and new immigrants; and,

14 WHEREAS, Bullet fought for the reopening of the Filipino Education Center and the rebuilding  
15 of the Bessie Carmichael Elementary School; and,

16 WHEREAS, Bullet was a fighter and there was never a battle to big for her; and,

17 WHEREAS, Bullet could be found wherever there was a battle to be fought or an Asian person  
18 needed help; and,

19 WHEREAS, Bullet is a veteran of many political battles both in the Philippines and in the Bay  
20 Area; and,

21 WHEREAS, Bullet is sorely missed and will not be forgotten; now, therefore, be it

22 RESOLVED, That the San Francisco Board of Supervisors urges the San Francisco Unified  
23 School District’s School Board to name a school after Filipino Community Leader/Activist Violeta


