2 **COMMENDING RICK RUVOLO FOR HIS OUTSTANDING DEDICATION**  
3 **AND COMMITMENT TO THE CLEAN AIR PROGRAM.**

5 WHEREAS, Rick Ruvolo began working at the Department of Administrative  
6 Services – Clean Air Program on October 1, 1993; and,

7 WHEREAS, During his tenure as Director of the Clean Air Program, Rick has  
8 worked tirelessly to promote commuter assistance, alternative fuel and clean air issues in  
9 the San Francisco Bay Area; and,

10 WHEREAS, Since his appointment to this position Rick has been able to secure  
11 over \$1,000,000 in grants toward incentives for the purchases of clean air vehicles; and,

12 WHEREAS, On May 9, 2000, Rick’s work was recognized at the U.S.  
13 Department’s Clean Cities Conference in San Diego; and,

14 WHEREAS, San Francisco received the U.S Department of Energy’s “Gold Star”  
15 Award, recognizing his successful efforts to expand Alternative Fuel Vehicle fueling and  
16 electric charging infrastructures throughout the Bay Area; and,

17 WHEREAS, San Francisco also received \$150,000 in incentive grants for the  
18 purchase of AFVs, \$75,000 to supplement other grants to help fund an electric vehicle  
19 and other AFV rental operation at SFO and \$30,000 to subsidize the private sector  
20 development of public access CNG station at 3<sup>rd</sup> and 23<sup>rd</sup> Streets of San Francisco; and,

21 WHEREAS, Rick Ruvolo is an excellent ambassador for the City of San  
22 Francisco; therefore, be it

23 RESOLVED, That the San Francisco Board of Supervisors commends the  
24 dedication of Rick Ruvolo; and, be it




