2 RESOLUTION DETERMINING THAT THE ISSUANCE OF A TYPE 20 OFF-SALE  
3 BEER AND WINE ALCOHOLIC BEVERAGE CONTROL LICENSE TO YOUSEF Y.  
4 ZUGHBABA, FOR U-SAVE DISCOUNT STORE LOCATED AT 2401 IRVING STREET,  
5 WILL SERVE THE PUBLIC CONVENIENCE AND NECESSITY OF THE PEOPLE OF  
6 THE CITY AND COUNTY OF SAN FRANCISCO, IN ACCORDANCE WITH SECTION  
7 23958.4 OF THE CALIFORNIA BUSINESS AND PROFESSIONS CODE. WITH  
8 CONDITIONS.

10 WHEREAS, Yousef Y. Zughbaba is seeking issuance of a Type 20 off-sale beer  
11 and wine alcoholic beverage control license for U-Save Discount, located at 2401 Irving  
12 Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly  
14 zoned; and

15 WHEREAS, The Police Department recommends that the liquor license  
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business  
18 and Professions Code, the Board of Supervisors of the City and County of San  
19 Francisco hereby determines for the foregoing reasons that the issuance of a Type 20  
20 off-sale beer and wine alcoholic beverage control license, to Yousef Y. Zughbaba for U-  
21 Save Discount, located at 2401 Irving Street will serve the public convenience and  
22 necessity of the people of the City and County of San Francisco.

23 Conditions: 1) Sales and delivery of alcoholic beverages shall be permitted only  
24 between the hours of 7:30 a.m. to 10:00 p.m. each day of the week except Sunday  
25 when the hours shall be 8:00 a.m. to 8:00 p.m. 2) There shall be no video machines

1 maintained upon the premises at any time. 3) The petitioner(s) shall be responsible for  
2 maintaining free of litter the area in front of and adjacent to the premises over which  
3 they have control. 4) No wine shall be sold with an alcoholic content greater than 15%  
4 by volume. 5) No beer products shall be sold in less than six pack quantities per sale.  
5 6) Wine shall not be sold in bottles or containers smaller than 750 ml, and wine-coolers  
6 shall not be sold in units of less than a four pack. 7) No person under the age of 21  
7 shall sell or package alcoholic beverages. 8) No pay phone will be maintained on the  
8 interior or exterior of the premises. 9) No more than 15% of the square footage of the  
9 premises will be used for the sale of alcoholic beverages.


