2 **APPOINTING GOVERNING BODY MEMBERS OF THE SAN FRANCISCO**  
3 **HEALTH AUTHORITY**

4 WHEREAS, the Board of Supervisors has established the San Francisco Health  
5 Authority as a separate legal entity for the purpose of providing health care services to  
6 Medi-Cal beneficiaries under a contract with the State Department of Health Services  
7 (San Francisco Administrative Code Sections 69.1 et seq.); and

8 WHEREAS, the authority to create the San Francisco Health Authority is set forth  
9 in State law (Welfare and Institutions Code Section 14087.36); and

10 WHEREAS, the Board of Supervisors made the initial appointments of the  
11 members of the governing body in 1995 (Resolution No. 113-95); and

12 WHEREAS, the term of office for governing body members is three years, which  
13 terms expire January 14, 2000; and

14 WHEREAS, the following three (3) nominees seek official Board of Supervisor  
15 appointments to the San Francisco Health Authority Governing Body; and




