2 DECLARING THE INTENTION OF THE BOARD OF SUPERVISORS TO VACATE  
3 JESSIE STREET BETWEEN SEVENTH AND EIGHTH STREETS IN CONNECTION  
4 WITH THE PROPOSED DEVELOPMENT OF A NEW FEDERAL OFFICE BUILDING BY  
5 THE GENERAL SERVICES ADMINISTRATION (GSA) AND CONVEY THE STREET  
6 AREA TO THE REDEVELOPMENT AGENCY OF THE CITY AND COUNTY OF SAN  
7 FRANCISCO (AGENCY) AT NO COST; SETTING THE HEARING DATE FOR <sup>July 31,</sup> ALL  
8 2000 at 3:00 p.m. for  
9 PERSONS INTERESTED IN THE PROPOSED VACATION OF THE STREET AREA; AND  
10 ADOPTING FINDINGS THAT THE VACATION AND CONVEYANCE ARE CONSISTENT  
11 WITH THE CITY'S GENERAL PLAN AND EIGHT PRIORITY POLICIES OF CITY  
12 PLANNING CODE SECTION 101.1.

15 WHEREAS, The Agency has filed a petition for the vacation of a certain street area, the  
16 general location and extent of which is Jessie Street between Seventh and Eighth Streets, as further  
17 described below (the "Street Area"); and

18 WHEREAS, The Street Area is shown in the Department of Public Works' SUR Map No.  
19 599, dated September 30, 1999, a copy of which is on file with the Clerk of the Board of Supervisors  
20 in File No. 001152 and is located within the Federal Office Building Redevelopment Project  
21 Area; and

23 WHEREAS, The vacation of the Street Area and conveyance to the Agency (in accordance  
24 with the terms and conditions of the Purchase and Sale Agreement, a copy of which is on file with the  
25 Clerk of the Board of Supervisors in File No. 001152 ) are necessary to complete the site assembly

1 for the proposed GSA office building and to fulfill the purposes of the Redevelopment Plan for the  
2 Federal Office Building Redevelopment Project Area as approved by the Board of Supervisors  
3 pursuant to Ordinance No. 403-97, adopted October 14, 1997; and

4 WHEREAS, Subject to the conditions specified in this resolution below, the Street Area is  
5 unnecessary for present or prospective public use; and  
6

7 WHEREAS, The public convenience and necessity require that the City reserve and except  
8 from the vacation of the Street Area solely the following: the non-exclusive easement and right for  
9 the benefit of PG&E, in, upon, and over those certain portions of the Street Area in which its  
10 respective in-place and functioning facilities are located, to the extent necessary to maintain, operate,  
11 repair and remove such existing lines of pipe, conduits, cables, wires, poles, and other convenient  
12 structures, equipment and fixtures for the operation of existing gas pipelines, telegraphic,  
13 telecommunications and telephone lines, and existing street lighting facilities, and existing facilities  
14 for the transportation or distribution of electric energy, and reasonable access to the foregoing  
15 facilities for the purposes set forth above; and  
16

17 WHEREAS, The public convenience and necessity further require that any reserved or  
18 excepted easement for the benefit of PG&E shall be terminated in whole or in part, as applicable,  
19 upon the expiration of ninety (90) days written notice from the Executive Director of the Agency that  
20 the easement must be terminated in order to carry out the purposes of the Redevelopment Plan for the  
21 Federal Office Building Redevelopment Project Area; and  
22

23 WHEREAS, Except as specifically provided above, the public convenience and necessity  
24 require no easements or other rights be reserved for any public utility facilities that are in place in the  
25

1 Street Area and that any rights based upon any such public utility facilities be extinguished upon the  
2 effectiveness of the vacation; and

3 WHEREAS, Any removal, relocation or abandonment of any in-place utilities required or  
4 permitted to be performed in connection with development of the site shall be done at no cost or  
5 expense to the City, provided that nothing herein shall be deemed to preclude any future owner of the  
6 Street Area from charging a third party for or otherwise causing a third party to bear the costs of such  
7 relocation where such charge or cost is otherwise permitted by law; and  
8

9 WHEREAS, On April 5, 1999 the Director of City Planning sent a letter, a copy of which is  
10 on file with the Clerk of the Board of Supervisors in File No. 001152 , wherein the Director found  
11 that the proposed vacation of Jessie Street and conveyance of the Street Area to the Agency are  
12 consistent with the City's General Plan, and with the Eight Priority Policies of City Planning Code  
13 Section 101.1; and  
14

15 WHEREAS, Section 787(a) of the San Francisco Public Works Code provides that the City  
16 and County will follow the procedure for vacating streets set forth in State law in the Streets and  
17 Highways Code and such rules and conditions as are adopted by the Board of Supervisors; now,  
18 therefore, be it

19 RESOLVED, That under Section 8320 of the California Streets and Highways Code, the  
20 Board of Supervisors hereby declares that it intends to order the vacation of the Street Area, as  
21 described in the map referred to above on file with the Clerk of the Board of Supervisors in File No.  
22 001152 ; and, be it  
23

24 FURTHER RESOLVED, That the Clerk of the Board of Supervisors and the Director of  
25 Property shall be authorized and the Clerk shall be directed to record (or cause to be recorded) a

1 certified copy of the Ordinance ordering such vacation as provided in Section 8325(a) of the  
2 California Streets and Highways Code, and thereupon such vacation shall be effective without any  
3 further action by the Board of Supervisors; and, be it

4 FURTHER RESOLVED, That the vacation proceeding of the Street Area is conducted under  
5 the general vacation procedures of the Public Streets, Highways and Service Easements Vacation  
6 Law (Streets and Highways Code Section 8320 et seq.); and, be it

7  
8 FURTHER RESOLVED, That notice is hereby given that on the 31st (~~—~~th) day  
9 of July, 2000, beginning at 3:00 p.m. in the Legislative Chambers of the Board of  
10 Supervisors, all persons interested in or objecting to the proposed vacation will be heard; and, be it

11 FURTHER RESOLVED, That the San Francisco Board of Supervisors adopts as its own and  
12 incorporates by reference herein as though fully set forth, the findings in the Director of Planning's  
13 letter referred to above, finding that the proposed vacation of Jessie Street and conveyance of the  
14 Street Area to the Agency are in conformity with the General Plan and are consistent with the Eight  
15 Priority Policies of Planning Code Section 101.1; and, be it


16  
17 FURTHER RESOLVED, That the Board of Supervisors directs the Clerk of the Board to  
18 transmit to the Department of Public Works a certified copy of this resolution, and the Board of  
19 Supervisors urges the Director of Public Works to publish or post this resolution promptly in the  
20 manner required by law and to give notice of the hearing of such contemplated action in the manner  
21 required by law.


