

1 [Transfer to General Fund - \$29,850,000]

2 **CONCURRING WITH THE PUBLIC UTILITIES COMMISSION'S FACT FINDING THAT A**
3 **FUND SURPLUS EXISTS IN THE UTILITIES WHICH CAN BE TRANSFERRED TO THE**
4 **GENERAL FUND.**

6 WHEREAS, Under Charter Section 16.103, the Public Utilities Commission (PUC) with the
7 concurrence of two thirds of the Board of Supervisors may authorize the transfer of any portion of
8 Utilities' surplus funds to the General Fund upon making stipulated finding of fact and judgment; and

10 WHEREAS, The PUC has received a report from the General Manager of Utilities
11 recommending Hetch Hetchy Water & Power transfer \$29,850,000 to the General Fund for FY2000-
12 2001; and,

14 WHEREAS, The Public Utilities Commission find the following to be true:

- 15 (a) That a surplus exists or is projected to exist after meeting the requirements of Section
16 16.103; and,
- 17 (b) That there is no unfunded operating or capital program which by its lack of funding
18 could jeopardize health, safety, water supply or power production; and
- 19 (c) That there is no reasonably foreseeable operating contingency which cannot be funded
20 without general fund subsidy, and
- 21 (d) That such a transfer of funds in all other respects reflects prudent utility practice, and

22 WHEREAS, The Commission has held a public hearing on the proposal; now, therefore, be it
23 **RESOLVED**, That the Public Utilities Commission is hereby authorized to budget Hetch
24 Hetchy's 2000-2001 General Fund contribution at \$29,850,000.


