1 [Approving Conveyance of certain land to the United States of America in Connection with the  
2 Federal Office Building Project]

3 APPROVING THE CONVEYANCE OF LAND BY THE REDEVELOPMENT AGENCY OF  
4 THE CITY AND COUNTY OF SAN FRANCISCO TO THE UNITED STATES OF AMERICA  
5 FOR THE FEDERAL OFFICE BUILDING PROJECT IN IMPLEMENTATION OF THE  
6 REDEVELOPMENT PLAN FOR THE FEDERAL OFFICE BUILDING PROJECT AREA; AND  
7 ADOPTING FINDINGS PURSUANT TO SECTION 33433 OF THE CALIFORNIA  
8 COMMUNITY REDEVELOPMENT LAW.

9 WHEREAS, The Redevelopment Agency of the City and County of San Francisco (the  
10 "Agency") prepared and approved the Redevelopment Plan for the Federal Office Building  
11 Redevelopment Project Area (the "Redevelopment Plan") in accordance with the  
12 requirements of the Community Redevelopment Law (Sections 33000 et seq. of the Health  
13 and Safety Code), and the Board of Supervisors adopted the Redevelopment Plan on October  
14 14, 1997; and

15 WHEREAS, The Agency acquired land within the Federal Office Building  
16 Redevelopment Project Area (the "Project Area") using tax increment funds from the Golden  
17 Gateway Redevelopment Project Area and the South of Market Earthquake Recovery  
18 Redevelopment Project Area pursuant to the fiscal merger of the project areas approved by  
19 the Board of Supervisors on October 14, 1997; and

20 WHEREAS, The Agency proposes to enter into that certain Real Property Conveyance  
21 Agreement (a copy of which is on file with the Clerk of the Board in File No. <sup>001151</sup>) with the  
22 United States of America acting by and through the General Services Administration ("GSA"),  
23 whereby the Agency will convey certain land to GSA at no cost for the purpose of constructing  
24 an approximately 675,000 gross square foot federal administrative office building; and

1           WHEREAS, On August 7, 2000, this Board of Supervisors adopted Ordinance No.  
2 196-00 ordering the vacation of a portion of Jessie Street and approving the conveyance  
3 thereof to the Agency at no cost, subject to the terms and conditions of the Agreement for  
4 Transfer of Real Estate between the City and the Agency, a copy of which is also on file with  
5 the Clerk of the Board in File No. 001153 ;

6           WHEREAS, Section 33220 of the Health and Safety Code authorizes, among other  
7 things, the City to sell or convey City-owned property within a redevelopment project area to  
8 the Redevelopment Agency with or without consideration for the purpose of aiding and  
9 cooperating in the undertaking and construction of redevelopment projects; and

10           WHEREAS, Section 33433 of the Health and Safety Code requires the Board of  
11 Supervisors, as the legislative body under Section 33433, to approve the Agency's sale of any  
12 land acquired with tax increment proceeds for development pursuant to the Redevelopment  
13 Plan; and

14           WHEREAS, In accordance with the requirements of Section 33433, the Agency has  
15 published a notice and made available a report (the "Report") regarding the proposed  
16 conveyance of land to GSA; now, therefore, be it

17 RESOLVED, The Board of Supervisors hereby finds, determines and declares, based on the  
18 record before it, including but not limited to the analyses and information contained in the  
19 Report that:

- 20           A. The proposed conveyance of land to GSA pursuant to the proposed Real Property  
21           Conveyance Agreement between the Agency and GSA will assist in the elimination  
22           of blight from the Project Area;
- 23           B. The proposed conveyance of land to GSA is consistent with the implementation  
24           plan adopted pursuant to Section 33490 of the Health and Safety Code for the  
25           Project Area; and


