10 America are a private organization and can bar gay troop leaders; and,

11 WHEREAS, Scouting For All is organizing a national day of protest at the Boy Scouts  
12 of America headquarters in Irving, TX and at Scout Council offices in major cities in every  
13 state; and,

14 WHEREAS, The national day of protest will be held on Monday, August 21, 2000; and,

15 WHEREAS, The national day of protest will provide an opportunity for Boy Scouts,  
16 adult leaders, concerned individuals, churches, and organizations who support the diversity of  
17 the human family to oppose the Boy Scouts of America's discrimination against gay youth  
18 and adults; now, therefore, be it

19 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
20 supports Eagle Scout Steve Cozza, Scott Cozza, and Scouting For All in their national day of  
21 protest against the Boy Scouts of America's discrimination against gay youth and adults.


