2 COMMENDING PIONEER PARK PROJECT FOR ITS OUTSTANDING LEADERSHIP IN THE  
3 RENOVATION OF PIONEER PARK.

5 WHEREAS, The Pioneer Park Project began when neighbors of Pioneer Park organized to find  
6 a solution to erosion and other problems in the Park; and,

7 WHEREAS, The Pioneer Project worked with the Recreation and Parks Department to create a  
8 community-based plan to build pedestrian and infrastructure improvements and generated broad  
9 community and civic support for that plan; and,

10 WHEREAS, The Pioneer Park Project raised nearly \$1 Million dollars to augment funds from  
11 the Department of Public Works and the Recreation and Parks Department to improve the park; and,

12 WHEREAS, These improvements will stem the erosion by facilitating pedestrian access to and  
13 through the Park and provide handicapped people access to an upper terrace and Coit Tower; and,

14 WHEREAS, Crosswalks, flashing traffic lights and improved signs will be installed to protect  
15 pedestrians and to warn motorists; and,

16 WHEREAS, The Pioneer Park Project volunteers have spent many weekends re-landscaping  
17 those areas that are not part of the reconstruction; now, therefore, be it

18 RESOLVED, That the community members of Pioneer Project have volunteered endless hours  
19 to design a community plan, carry out a successful six-year fundraising campaign, and replant major  
20 parts of Pioneer Park; and, be it

21 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San  
22 Francisco commends the Pioneer Park Project for its outstanding leadership in the renovation of  
23 Pioneer Park.




