2 AUTHORIZING THE OFFICE OF THE DISTRICT ATTORNEY TO RETROACTIVELY
3 AND EXPEND A GRANT IN THE AMOUNT OF \$150,000 MADE AVAILABLE THROUGH
4 THE CALIFORNIA OFFICE OF CRIMINAL JUSTICE PLANNING FOR THE OPERATION
5 OF THE STATUTORY RAPE VERTICAL PROSECUTION PROGRAM ("SRVP").

6 WHEREAS, The District Attorney's Office and the City and County
7 of San Francisco desire to continue a certain project designated the
8 Statutory Rape Vertical Prosecution Program with funds made available
9 through the Office of Criminal Justice Planning (OCJP); and,

10 WHEREAS, The District Attorney proposes to maximize use of
11 available grant funds on program expenditures by not including
12 indirect costs in the grant budget; now, therefore, be it

13 RESOLVED, That the Board of Supervisors hereby waives inclusion
14 of indirect costs in the grant budget, and be it

15 FURTHER RESOLVED, That the District Attorney of the City and
16 County of San Francisco, is authorized , retroactively,
17 proposal to OCJP and is authorized , retroactively,
18 the City and County of San Francisco the attached Grant Award
19 Agreement including any augmentations, extensions or amendments
20 thereto; and be it

21 FURTHER RESOLVED, That in the event the Office of Criminal
22 Justice Planning consents to fund the project, the District Attorney
23 of the City and County of San Francisco is authorized , retroactively,
24 amend said project except as any amendment would increase any hard


1 matching fund obligations of the City and County of San Francisco
2 pursuant to the contract; and be it

3 FURTHER RESOLVED, That the grant funds received hereunder
4 shall not be used to supplant local funds that would, in the absence
5 of the Statutory Rape Vertical Prosecution Program be made available
6 to support the prosecution of statutory rape; and be it


7 FURTHER RESOLVED, That it is agreed that any liability
8 arising out of the performance of this Grant Award contract including
9 Civil Court actions for damages shall be the responsibility of the
10 grantee and the authorizing agency. The State of California and OCJP
11 disclaim responsibility for any such liability; and

12 THEREFORE, IT IS HEREBY RESOLVED, that the District
13 Attorney of the City and County of San Francisco is authorized to
14 retroactively
15 /apply for, accept and expend funds made available through the Office
16 of Criminal Justice Planning for the project entitled Statutory Rape
17 Vertical Prosecution (SRVP) in the amount of \$150,000 for Statutory
18 Rape Vertical Prosecution purposes, and waiving indirect cost due to
19 funding constraints.


