2 AUTHORIZING THE CHIEF OF POLICE FOR THE CITY AND COUNTY OF SAN
3 FRANCISCO TO ACCEPT AND EXPEND FUNDS MADE AVAILABLE THROUGH THE
4 OFFICE OF CRIMINAL JUSTICE PLANNING FOR A PROJECT ENTITLED "JAMES
5 DENMAN MIDDLE SCHOOL SAFETY PROGRAM" AND WAIVING INDIRECT COSTS DUE
6 TO FUNDING CONSTRAINTS.

8 WHEREAS, the Chief of Police of the City and County of San
9 Francisco desires to undertake a certain project designated "James
10 Denman Middle School Safety Program" to be funded from funds made
11 available through the Office of Criminal Justice Planning (herein
12 referred to as OCJP); and,

13 WHEREAS, the San Francisco Police Department's School Resource
14 Officer program will implement a safety program at the James Denman
15 Middle School to improve school safety, engage chronic truants in
16 special programs and services to stay in school; and,

17 WHEREAS, the Department proposes to maximize use of available
18 grant funds on program expenditures by not including indirect costs
19 in the grant budget due to funding constraints; now, therefore, be it

20 RESOLVED, That the Chief of Police of the City and County of San
21 Francisco is authorized on behalf of the City and County of San
22 Francisco to accept and expend continued funding for this project
23 from OCJP, and waiving indirect costs due to funding constraints; be

2 inclusion of indirect costs in the grant budget; be it


3 FURTHER RESOLVED, That the Chief of Police is authorized to
4 execute on behalf of the City and County of San Francisco the
5 necessary Grant Award Agreement for this project including any
6 extensions, funding augmentations from OCJP, or amendments thereof;
7 be it

8 FURTHER RESOLVED, That it is agreed that any liability arising
9 out of the performance of this Grant Agreement, including civil court
10 actions for damages, shall be the responsibility of the grantee and
11 the authorizing agency. The State of California and OCJP disclaim
12 responsibility for and such liability; and be it


13 FURTHER RESOLVED, that grant funds received hereunder shall not
14 be used to supplant expenditures controlled by this body; and be it

15 FURTHER RESOLVED, That the new positions authorized under the
16 grant shall be designated as "G" or "Grant-funded" positions, which
would terminate when the grant expires.






