2 APPOINTING ALVIN ALVAREZ, ROBERT SCHMITT, TERM ENDING DECEMBER 31,
3 2002, AND SHAWN MAURICE RICHARD, TERM ENDING JUNE 30, 2003, TO THE
4 DELINQUENCY PREVENTION COMMISSION; RESIDENCY WAIVED.

6 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
7 does hereby appoint the hereinafter designated persons to serve as members of the
8 Delinquency Prevention Commission, pursuant to the provisions of the San Francisco
9 Administrative Code, Section 20.51, for the term specified:

11 Alvin Alvarez, succeeding Ted Frazier, (Seat No. 4, must have interest in and be
12 knowledgeable regarding juvenile delinquency prevention), for the unexpired portion of a four-
13 year term ending December 31, 2002;

14 Robert Schmitt, succeeding Ollie Bryant, Jr, (Seat No. 5, must have interest in and be
15 knowledgeable regarding juvenile delinquency prevention), for the unexpired portion of a four-
16 year term ending December 31, 2002;

17 Shawn Maurice Richard, succeeding Alan Oliver, (Seat No. 18, must have interest in
18 and be knowledgeable regarding juvenile delinquency prevention), for the unexpired portion
19 of a four-year term ending June 30, 2003; and, be it

21 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 22 1. The membership of the Delinquency Prevention Commission has a goal to be
23 representative of the diversity of the City and County of San Francisco.

- 1 2. Applicant Alvin Alvarez, a new appointee, who is not a resident of San Francisco, is
2 a person with experience that uniquely qualifies him/her to serve on the
3 Delinquency Prevention Commission.
- 4 3. The Delinquency Prevention Commission has attempted to fill the position, for
5 which Alvin Alvarez was nominated, with an individual who is a City resident and
6 who has the specific experience, skills, and qualifications, but has been unable to
7 do so at this time. The Rules Committee has certified that Alvin Alvarez is qualified
8 to serve on the Delinquency Prevention Commission.
- 9 4. After exercising due diligence, the Board of Supervisors concludes that there is no
10 other possible representative, who is a resident of San Francisco and who has the
11 specific experience, skills, or qualifications possessed by this applicant, and who is
12 willing to serve on the Delinquency Prevention Commission at this time; and, be it

13 FURTHER RESOLVED, That the Board of Supervisors waives the residency
14 requirement for Alvin Alvarez, as allowed in cases where no qualified City resident, willing to
15 serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)
16 appointed to boards, commissions, and advisory bodies established by legislative act of the
17 Board of Supervisors to be resident(s) of the City and County of San Francisco.


