3 AUTHORIZING THE DEPARTMENT OF PUBLIC HEALTH, PUBLIC HEALTH DIVISION,  
4 COMMUNITY MENTAL HEALTH SERVICES TO <sup>RETROACTIVELY</sup> ENTER INTO A COOPERATIVE  
5 PROGRAM AGREEMENT WITH THE DEPARTMENT OF REHABILITATION SAN  
6 FRANCISCO DISTRICT, INCLUDING A REQUIRED MATCH OF ~~\$253,296~~ <sup>\$264,477</sup>, AND WHICH  
7 DOES NOT INCLUDE INTELLECTUAL PROPERTY INDEMNIFICATION AND FALSE  
8 CLAIMS CLAUSES, TO PROVIDE VOCATIONAL SERVICES TO MENTALLY-ILL  
9 PSYCHIATRIC CLIENTS.

10 WHEREAS, The Department of Public Health, Public Health Division, Community  
11 Mental Health Services, is the Designated Cooperative Agency in the provision of State funding  
12 for vocational services to mentally ill psychiatric clients in San Francisco; and,

13 WHEREAS, The Department of Public Health, Public Health Division, Community  
14 Mental Health Services, annually enters into a Cooperative Program Agreement with the  
15 Department of Rehabilitation San Francisco District; and,

16 WHEREAS, The State Department of Rehabilitation requires an annual Board of  
17 Supervisor's Resolution designating approval of the Cooperative Program Agreement (the  
18 "Agreement") copies of which are on file with the Clerk of the Board of Supervisors in File  
19 No. 001054 ; and,

20 WHEREAS, The Agreement includes a required local cash match in the amount of  
21 ~~\$253,296~~ <sup>\$264,477</sup> from the San Francisco Community Mental Health General Fund; and,

22 WHEREAS, The Agreement authorizes direct funding from the Department of  
23 Rehabilitation San Francisco District to two Case Service Contracts in the total amount of  
24 ~~\$837,956~~ <sup>\$838,228</sup> for the delivery of vocational rehabilitation services to clients of the Department of  
25 Public Health, Community Mental Health Services; and,

WHEREAS, The Agreement does not contain certain provisions described below, which  
are required under the Administrative Code unless waived by the Board of Supervisors; and,

WHEREAS, The Board of Supervisors desires to authorize the Department of Public  
Health to enter into the Agreement; now, therefore be it

4 mentally ill psychiatric clients; and, be it


5 FURTHER RESOLVED, That the Director of Health is authorized to enter into the

7 FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement  
8 contained in Sections 21.21 of the Administrative Code that the Agreement include an  
9 indemnification of the City by the Department of Rehabilitation San Francisco District for the  
10 infringement of patent rights, copyright, trademark, and other intellectual property rights; and, be  
11 it

12 FURTHER RESOLVED, That the Board of Supervisors hereby waives the requirement  
13 that the Agreement include a paragraph reciting the false claims provisions contained in Section  
14 21.35 of the Administrative Code; and, be it

15 FURTHER RESOLVED, That the Board of Supervisors authorizes the Director of  
16 Health to enter into similar agreements with the Department of Rehabilitation San Francisco  
17 District if the contract recurs or is renewed.




