12 beer and wine public premises license and the transfer of a Type 21 off-sale general  
13 alcoholic beverage control license from 80 Grant Avenue to 233 Geary Street; and

14 WHEREAS, The City Planning Department has verified that the area is properly  
15 zoned; and

16 WHEREAS, The Police Department recommends that the liquor license  
17 application be approved with a condition; now, therefore, be it

18 RESOLVED, That in accordance with Section 23958.4 of the California Business  
19 and Professions Code, the Board of Supervisors of the City and County of San  
20 Francisco hereby determines for the foregoing reasons that the issuance of a Type 42  
21 on-sale beer and wine public premises license and the transfer of a Type 21 off-sale  
22 general alcoholic beverage control license from 80 Grant Avenue to 233 Geary Street  
23 will serve the public convenience and necessity of the people of the City and County of  
24 San Francisco.

2 permitted only between the hours of 9:00 a.m. and 8:00 p.m. each day of the week.


