2 AUTHORIZING THE DEPARTMENT OF PUBLIC WORKS TO ACCEPT AND EXPEND A  
3 GRANT IN THE AMOUNT OF \$100,000 FROM THE METROPOLITAN TRANSPORTATION  
4 COMMISSION'S SURFACE TRANSPORTATION PROGRAM (STP) EXCHANGE PROGRAM  
5 FOR IMPROVEMENTS AT SOUTHWEST GATEWAY.

7 WHEREAS, The Metropolitan Transportation Commission (MTC) has  
8 received from the California Department of Transportation and the  
9 Santa Clara Valley Transportation Agency, successor agency to the  
10 Santa Clara Traffic Authority, funds to reimburse federal Surface  
11 Transportation Program (STP) funds previously advanced to the Santa  
12 Clara Traffic Authority to complete the Route 85/17 interchange; and,

13 WHEREAS, MTC adopted Resolution No. 3018 on October 1, 1997 that  
14 established the STP Exchange Program; and,

15 WHEREAS, MTC has recommended programming \$100,000 in STP  
16 Exchange funds for the Department of Public Works' (DPW) Southwest  
17 Gateway Improvement Project; and,

18 WHEREAS, STP Exchange funds will cover all eligible direct  
19 project costs with no required local matching funds; and,

20 WHEREAS, Indirect costs are ineligible according to MTC rules  
21 and regulations; now, therefore, be it

22 RESOLVED, That the Board of Supervisors does hereby authorize  
23 the Director of Public Works to accept and expend \$100,000 in state  
24 STP Exchange funds for the Southwest Gateway Improvement Project and  
25 to execute any and all documents necessary therefore.




