2 TRANSFERRING JURISDICTION OF REAL PROPERTY FROM THE DEPARTMENT OF  
3 ADMINISTRATIVE SERVICES TO THE DEPARTMENT OF PUBLIC WORKS  
4 IDENTIFIED AS ASSESSOR'S BLOCK 341 LOT NOS. 13 AND 14 AND SUB-SURFACE  
5 AREA OF CYRIL MAGNIN STREET BETWEEN LOT NOS. 13 AND 14 (HALLIDIE  
6 PLAZA).

9 WHEREAS, The City and County of San Francisco, a municipal corporation, is the owner of  
10 Lot Nos. 13 and 14 in Block 341 in San Francisco, California, which property is under the jurisdiction  
11 of the Department of Administrative Services; and

12 WHEREAS, The Director of Public Works and the Director of Administrative Services both  
13 concur that the subject property as shown highlighted on the map labeled Exhibit "A", a copy of which  
14 is on file with the Clerk of the Board of Supervisors, be transferred to the Department of Public  
15 Works at no cost and continue to be used as a public plaza area; and

17 WHEREAS, A General Plan request to the City's Planning Department as to conformity with  
18 the General Plan and findings relative to Planning Code Section 101.1 of said proposed jurisdictional  
19 transfer are not required due to the fact that there will not be a change in use or ownership; and

21 WHEREAS, In accordance with the provisions of Section 23.11 of the San Francisco  
22 Administrative Code, the Director of Property has reported to the Mayor that the historical cost of the  
23 subject property is \$2,800,000 and in his opinion the subject property can be most appropriately and  
24 advantageously used by the Department of Public Works, and has therefore recommended that the  
25 transfer be made at no cost; and

WHEREAS, The Mayor recommends the proposed transfer of the subject property; now, therefore, be it






