1 [Parking Regulations]

2 ENACTING AND RESCINDING PARKING REGULATIONS AT VARIOUS LOCATIONS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
4 and the San Francisco Traffic Code, the following regulations governing the parking of
5 vehicles are hereby enacted or rescinded as designated below:

6 **DIAGONAL (60-DEGREE ANGLE) PARKING - ESTABLISH**

7 ~~Beale Street, east side, from 555 feet to 613 feet north of Bryant Street (58-foot~~
8 ~~zone, accommodating 6 angled parking stalls)~~

9 ~~Beale Street, east side, from Bryant Street to 410 feet northerly (410-foot zone,~~

11 ~~Beale Street, east side, from Folsom Street to 223 feet southerly (223-foot zone,~~

20 **RESIDENTIAL PERMIT PARKING AREA "I" (1-HOUR TIME LIMIT, 9 AM - 6 PM,**
21 **MONDAY THROUGH SATURDAY) - ESTABLISH**

22 20th Street, both sides, between Harrison and Folsom Streets (3200 block)

23 21st Street, both sides, between Harrison and Folsom Streets (2900 block)

24 Treat Avenue, both sides, between 20th and 21st Streets (700 block)


