16 108, and Section 110 Table I-K, and Sections 41.10, and 41.20 of Chapter 41 of the San  
17 Francisco Administrative Code, this Board does hereby confirm said Report and delinquent  
18 charges incurred as modified, as shown on the report on file in the Office of the Clerk of the  
19 Board of Supervisors, File No. 001416 and by reference made a part hereof; and be it.

20 FURTHER RESOLVED, That the Clerk of the Board is hereby directed to transmit a  
21 certified copy of this resolution and its attached report to the Tax Collector who shall cause the  
22 amount of said assessment in each case to be added to the next regular bill for taxes levied  
23 against the real property as specified on said report, with a clear notation of the source of said  
24 levy thereof on said bill.


