 7 AND RESTITUTION PROGRAM, AN AGENT OF THE STATE OF CALIFORNIA, FOR A
 8 PROJECT ENTITLED "DISTRICT ATTORNEY'S CONTRACT - CRIMINAL RESTITUTION
 9 COMPACT", FOR THE TWELVE MONTH PERIOD July 1, 2000 THROUGH June 30,
 2001.

10 WHEREAS, The District Attorney and the City and County of San
 11 Francisco desire to enter into an agreement between the District
 12 Attorney's Office and the State Board of Control Victims of Crime and
 13 Restitution Program in accordance with Government Code Section 13835,
 14 for the purpose of working with the county criminal justice system to
 15 ensure restitution fines and orders are properly administered; and

16 WHEREAS, the funds received hereunder shall not be used to
 17 supplant local funds that would, in the absence of the California
 18 Victims of Crime and Restitution Programs, be made available to
 19 support the assistance of victims and witnesses of crime, now,
 20 therefore, be it,

21 RESOLVED, That the District Attorney of the City and County of
 22 retroactively
 23 San Francisco is hereby authorized to/contract for, accept and expend
 24 funds in the amount of \$63,952, waiving indirect costs, for a project
 25 entitled "District Attorney Contract - Criminal Restitution Compact"
 for the twelve-month period July 1, 2000 through June 30, 2001, and,






