

1 [SB 1462 Humane Care of Rodeo Animals]

2 **URGING THE CALIFORNIA ASSEMBLY, SENATE AND GOVERNOR DAVIS TO SUPPORT**  
3 **AND APPROVE SB 1462 (D-PERATA), THE HUMANE CARE OF RODEO ANIMALS**  
4 **INITIATIVE.**

5 WHEREAS, Senate Bill 1462 (Sponsored by Democrat Dennis Perata, Oakland) would  
6 require the management of any professionally sanctioned or amateur rodeo intending to  
7 perform in any city, county or city and county to notify, at least 14 days prior to the rodeo's first  
8 performance, the entity providing animal control services within the jurisdiction; and

9 WHEREAS, Senate Bill 1462 would require rodeo management to ensure there is a  
10 licensed to practice in this state, or veterinary technician, as specified, present at all times  
11 during the; and

12 WHEREAS, The attending veterinarian, veterinary technician, humane officer, or animal  
13 control officer would have complete access to the site of any event in the rodeo that uses  
14 animals; and

15 WHEREAS, The veterinarian would be authorized, for good cause, to declare any  
16 animal unfit for use in any rodeo even; and

17 WHEREAS, The bill would provide for treatment, and specified duties of the  
18 veterinarian and rodeo management, with respect to injured animals or animals in holding; and

19 WHEREAS, This bill would provide a specified exemption for the National High School  
20 Rodeo Association, the National Intercollegiate Rodeo Association, and junior; and

21 WHEREAS, A violation would be punishable by fines; now, therefore, be it

22 **RESOLVED**, That the Board of Supervisors of the City and County of San Francisco  
23 hereby urges the California Assembly, the California Senate and Governor Davis to support  
24 and approve Senate Bill 1462.
