2 **WAIVING PARKING CONTROL OFFICER FEE OF \$385.60 CHARGED TO RACHEL**
3 **KAPLAN FOR ORGANIZING AND STAGING A PERFORMANCE PROTEST ON AUGUST**
4 **22, 2000.**

5 WHEREAS, A performance protest was convened on August 22, 2000 from 7:00 to
6 12:00 PM to call attention to the plight of dance performance artists, choreographers, film
7 makers, musicians and other members of the performing arts community; and

8 WHEREAS, Many dance performance studios have either been evicted or displaced
9 because of a recent dramatic escalation of rents in San Francisco with some rents going up
10 nearly 500%; and

11 WHEREAS, Dancers, musicians, actors, puppet performance artists, poets as well as
12 community leaders and concerned citizens from the all over the San Francisco participated in
13 the event to voice their concerns about the imperiled dance performance and arts community;
14 and

15 WHEREAS, The local dance performance community, second only to New York City, is
16 endangered by escalating rents, severe shortage of rehearsal space, and displacement by
17 high tech and Internet companies ; and

18 WHEREAS, The local dance performance and arts community contributes significantly
19 cultural vibrancy and uniqueness to the City and it is in the best interest of the City to devise
20 strategies to preserve and enhance artistic creativity and economic viability of this community;
21 and

22 WHEREAS, The performance protest event was held on August 22, 2000 in which 22nd
23 Street and blocked off from Mission Street to Bartlett Street to vehicular traffic and required the
24 assistance of Parking Calming Officers to monitor traffic flow of the intersection; now therefore
25 be it




