

1 [AB 2142 Gender Nondiscrimination Bill]  
2 URGING CALIFORNIA GOVERNOR GRAY DAVIS TO SUPPORT AB 2142, THE GENDER  
3 NONDISCRIMINATION BILL.

4  
5 WHEREAS, The Fair Employment and Housing Act makes illegal employment and  
6 housing discrimination based upon race, religious creed, color, national origin, ancestry,  
7 physical disability, mental disability, medical condition, marital status, sex, sexual orientation,  
8 or age; and,

9 WHEREAS, In 1993, AB 675 clarified that "harassment because of sex" under the Fair  
10 Employment and Housing Act includes, but is not limited to, sexual harassment, gender  
11 harassment, and harassment on the basis of pregnancy, however, until the last legislative  
12 session, there was no definition contained in the codes for "gender"; and,

13 WHEREAS, With passage of AB 1999 (Kuehl), Ch. 933, Statutes of 1999, a definition  
14 of gender now exists in the Penal Code; and,

15 WHEREAS, The California State Legislature is currently considering Assembly Bill  
16 2142, the Gender Nondiscrimination Bill; and,

17 WHEREAS, The Gender Nondiscrimination Bill would clarify that for purposes of the  
18 Fair Employment and Housing Act discrimination on the basis of "sex" includes gender  
19 discrimination; and,

20 WHEREAS, AB2142 would reference the existing Penal Code definition for purposes  
21 of clarifying the entire Fair Employment and Housing Act; and,

22 WHEREAS, AB 2142 would help to ensure equal opportunities for all Californians by  
23 protecting against discrimination based on gender stereotyping; and,

24 WHEREAS, Assembly Bill 2142 is on file with the Clerk of the Board of Supervisors in  
25 File No. 001567 ; and,

19 Mayor, with a request that he transmit copies to the delegation from San Francisco in the  
20 State Legislature, as well as Governor Davis, with a request they take all action necessary to  
21 achieve the objectives of this resolution.




