9 help artists hone their talents; and,

10 WHEREAS, Theatre Bay Area publishes Callboard Magazine, the Theater Directory,
11 the Performance & Rehearsal Space Directory, and other publications for theater companies,
12 theater workers, and theater lovers; and,

13 WHEREAS, Theatre Bay Area administers the Mary Mason Memorial Lemonade Fund,
14 a confidential resource for critically ill theater workers who are in need of supplemental
15 financial assistance; and,

16 WHEREAS, In partnership with the Dancers' Group Studio Theater, Theatre Bay Area
17 conducts CA\$H Workshops, a new grants program designed by artists for artists to support
18 professionally oriented theater and dance artists and small companies with budgets under
19 \$100,000 ; and,

20 WHEREAS, Theatre Bay Area will celebrate 25 years of accomplishments, a vibrant
21 arts community, and the launch of the 2000-2001 season on September 25, 2000; now,
22 therefore, be it

23 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
24 commends Theatre Bay Area upon its 25th anniversary; and, be it
