2 ENACTING AND RESCINDING TRAFFIC REGULATIONS ON VARIOUS STREETS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
4 and the San Francisco Traffic Code, the following regulations governing the movement of
5 vehicles are hereby enacted or rescinded as designated below:

6 **YIELD SIGNS - ESTABLISH**

7 Faxon Avenue, southbound, at Northwood Drive

8 Plymouth Avenue, southbound, at Northwood Drive

9 **NO LEFT TURNS - ESTABLISH**

10 Persia Avenue, westbound, at Sunnydale Avenue

11 San Bruno Avenue, both directions, between Silliman and Felton Streets (prohibits
12 mid-block left turns)

13 **~~NO STOPPING OR WAITING IN PARKING AISLE - ESTABLISH~~**

14 ~~18th Avenue, off-street parking lot, between Geary Boulevard and Anza Street~~

15 ~~8th Avenue and Irving Street, off-street parking lot~~

16 **TOW-AWAY LANE MUST TURN RIGHT - ESTABLISH**

17 6th Street, northbound, at Folsom Street

18 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

19 Potrero Avenue, east side, between Division and Alameda Streets

Potrero Avenue, east side, between Division and Alameda Streets




