12 removal from their homes; and,

13 WHEREAS, FSSBA's Respite Program has provided over 500,000 hours of respite to  
14 over 2500 families and its Family Preservation Program has served over 800 families and  
15 more than 2000 children; and,

16 WHEREAS, On October 17, 2000, Family Support Services of the Bay Area will  
17 celebrate its tenth anniversary with an awards dinner honoring former respite clients Deborah  
18 Ross and Phil Chun, corporate partner Goldman Insurance Services GIVE Committee, and  
19 past FSSBA Board President Robin Tucker; now, therefore, be it

20 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
21 commends Family Support Services of the Bay Area upon its 10<sup>th</sup> anniversary; and, be it
