

[Installation of Speed Bumps on Shotwell Street]

1 URGING THE SAN FRANCISCO DEPARTMENT OF PARKING AND TRAFFIC TO INSTALL
2 SPEED BUMPS ON SHOTWELL STREET BETWEEN SEVENTEENTH AND EIGHTEENTH
3 STREETS AND OTHER APPROPRIATE TRAFFIC CALMING MEASURES TO PROMOTE
4 PEDESTRIAN SAFETY IN THE AREA AND MITIGATE PUBLIC NUISANCE AND QUALITY
5 OF LIFE VIOLATIONS.

7 WHEREAS, The 300 Block of Shotwell Street, bounded by Eighteenth and Nineteenth
8 Streets, consist of mixed residential units and light industrial businesses;
9 and,

10 WHEREAS, There is an increasing number of commercial buildings being converted
11 from industrial to residential use and
12 the number of residents has been steadily increasing;

13 WHEREAS, The buildings along the 200 and 400 Block of Shotwell Street are
14 primarily occupied by light industrial businesses and all through the evening and early morning
15 hours the 200 and 400 blocks of Shotwell Street are congregating sites for prostitutes, johns,
16 drug dealers and drug buyers;

17 WHEREAS, The residents of the 300 Block of Shotwell not only must endure cars
18 speeding through the narrow street, but experience also endure the stream of cars coming into
19 the neighborhood to solicit prostitutes and/or buy illegal drugs; and

20 WHEREAS, Residents and merchants are concerned about pedestrian safety,
21 especially children and seniors that live in the neighborhood; and

1 WHEREAS, Neighbors have expressed their desire for the City to take measures to
2 address the issue of pedestrian and traffic safety in the area, especially the installation of
3 speed bumps along Shotwell Street ; now therefore be it

4 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
5 urge the Department of Parking and Traffic to install speed humps along Shotwell Street
6 between Seventeenth and Eighteenth Streets as well as other traffic calming measures in
7 order to promote pedestrian safety in the neighborhood and mitigate public nuisance and
8 quality of life violations.




