2 RESOLUTION DETERMINING THAT THE ISSUANCE OF A TYPE 21 OFF-SALE  
3 GENERAL ALCOHOLIC BEVERAGE CONTROL LICENSE TO VLADIMIR  
4 VERKHOLAZ, RIMMA VERKHOLAZ, AND GARY VERKHOLAZ, FOR EUROPEAN  
5 FOOD WHOLESALE MARKET LOCATED AT 3032 - 3038 CLEMENT STREET, WILL  
6 SERVE THE PUBLIC CONVENIENCE AND NECESSITY OF THE PEOPLE OF THE  
7 CITY AND COUNTY OF SAN FRANCISCO, IN ACCORDANCE WITH SECTION  
8 23958.4 OF THE CALIFORNIA BUSINESS AND PROFESSIONS CODE; WITH  
9 CONDITIONS.

11 WHEREAS, Vladimir Verkhola, Rimma Verkhola and Gary Verkhola are  
12 seeking issuance of a Type 21 off-sale general alcoholic beverage control license for  
13 European Food Wholesale Market, located at 3032 - 3038 Clement Street; and,

14 WHEREAS, The City Planning Department has verified that the area is properly  
15 zoned; and

16 WHEREAS, The Police Department recommends that the liquor license  
17 application be approved with conditions; now, therefore, be it

18 RESOLVED, That in accordance with Section 23958.4 of the California Business  
19 and Professions Code, the Board of Supervisors of the City and County of San  
20 Francisco hereby determines for the foregoing reasons that the issuance of a Type 21  
21 off-sale general alcoholic beverage control license, to Vladimir Verkhola, Rimma  
22 Verkhola and Gary Verkhola for European Food Wholesale Market, located at 3032 -  
23 3038 Clement Street will serve the public convenience and necessity of the people of  
24 the City and County of San Francisco.

1           Conditions: 1) Sales and delivery of alcoholic beverages shall be permitted only  
2 between the hours of 10:00 a.m. and 8:00 p.m. each day of the week. 2) The petitioner  
3 shall be responsible for maintaining free of litter the area in front of and adjacent to the  
4 premises over which they have control. 3) No wine shall be sold with an alcoholic  
5 content greater than 15% by volume. 4) Wine shall not be sold in bottles or containers  
6 smaller than 750 ml, and wine coolers shall not be sold in units of less than a four  
7 pack. 5) No person under the age of 21 shall sell or package alcoholic beverages. 6)  
8 No more than 10% of the square footage of the premise will be used for the sale of  
9 alcoholic beverages.


