2 RESOLUTION DETERMINING THAT THE TRANSFER OF A TYPE 21 OFF-SALE
3 GENERAL ALCOHOLIC BEVERAGE CONTROL LICENSE FROM 1451 CHURCH
4 STREET TO 213 SUTTER STREET TO NASSIR A. ZUGHAYER FOR SAMMY'S
5 SMOKE & SNACKS TO UPGRADE ITS CURRENT TYPE 20 BEER AND WINE
6 LICENSE, WILL SERVE THE PUBLIC CONVENIENCE AND NECESSITY OF THE
7 PEOPLE OF THE CITY AND COUNTY OF SAN FRANCISCO, IN ACCORDANCE
8 WITH SECTION 23958.4 OF THE CALIFORNIA BUSINESS AND PROFESSIONS
9 CODE; WITH CONDITIONS.

11 WHEREAS, Nassir A. Zughayer is seeking transfer of a Type 21 off-sale general
12 alcoholic beverage control license for Sammy's Smoke and Snacks located at 213
13 Sutter Street; and,

14 WHEREAS, The City Planning Department has verified that the area is properly
15 zoned; and,

16 WHEREAS, The Police Department recommends that the liquor license
17 application be approved with conditions; now, therefore, be it

18 RESOLVED, That in accordance with Section 23958.4 of the California Business
19 and Professions Code, the Board of Supervisors of the City and County of San
20 Francisco hereby determines for the foregoing reasons that the transfer of a Type 21
21 off-sale general alcoholic beverage control license from 1451 Church Street to 213
22 Sutter Street for Nassir A. Zughayer for Sammy's Smoke and Snacks, to upgrade its
23 current Type 20 beer and wine license, will serve the public convenience and necessity
24 of the people of the City and County of San Francisco.

1 Conditions: 1) Sales and delivery of alcoholic beverages shall be permitted only
2 between the hours of 8:00 a.m. and 10:00 p.m. each day of the week. 2) The petitioner
3 shall be responsible for maintaining free of litter the area in front of and adjacent to the
4 premises over which they have control. 3) No wine shall be sold with an alcoholic
5 content greater than 15% by volume. 4) Wine shall not be sold in bottles or containers
6 smaller than 750 ml, and wine coolers shall not be sold in units of less than a four
7 pack. 5) No person under the age of 21 shall sell or package alcoholic beverages.


