

1 [Resolution to approve Refugee County Plan and accept and expend federal funds]

2 **Resolution approving the San Francisco Federal Fiscal Year 2000 Refugee County**  
3 **Plan and authorizing the Private Industry Council of San Francisco, Inc. to accept**  
4 **and expend, retroactive to October 1, 2000, \$908,134 of federal refugee funds in**  
5 **conformity with the Refugee County Plan.**

7 WHEREAS, The Private Industry Council of San Francisco, Inc. (PIC), by  
8 authorization of this Board of Supervisors acts with the approval of the Department of  
9 Human Services for the City and County of San Francisco in administering federal Refugee  
10 funds awarded to San Francisco; and

11 WHEREAS, The Refugee Committee is in an advisory capacity to the PIC with  
12 respect to those funds; and

13 WHEREAS, The staff of the PIC, in consultation with the Refugee Committee, has  
14 prepared the 2000 Refugee County Plan as required by the State Department of Social  
15 Services, and that the Refugee County Plan describes the uses of the refugee funds for the  
16 Federal Fiscal Year (FFY) beginning October 1, 2000; and

17 WHEREAS, The State has issued preliminary allocations for Refugee Employment  
18 Social Services (RESS) funds (\$193,354) and Targeted Assistance (TA) funds (\$714,780)  
19 for a preliminary total of \$908,134 for services to refugees in San Francisco; now therefore,  
20 be it

21 RESOLVED, That the Refugee County Plan for San Francisco is approved, and be it

22 FURTHER RESOLVED, That the President of the PIC is authorized by the Board of  
23 Supervisors to accept and expend, retroactive to October 1, 2000, \$908,134 of federal  
24 refugee funds in conformity with the Refugee County Plan, and be it

25 FURTHER RESOLVED, That the PIC is authorized by the Board of Supervisors to  
26 amend the Refugee County Plan as may be requested by the State Department of Social  
27 Services or its designee.


