

1 DESIGNATING TEMPORARY SELLING SPACES IN THE DOWNTOWN AREA AND AT  
2 HARVEY MILK PLAZA FOR STREET ARTISTS CERTIFIED BY THE ART  
3 COMMISSION, CITY AND COUNTY OF SAN FRANCISCO, FOR THE WINTER HOLIDAY  
4 SEASON, 2000, BEGINNING ON NOVEMBER 15, 2000 AND ENDING ON JANUARY  
5 15, 2001.

6  
7 WHEREAS, The Street Artists Ordinance adopted by the voters  
8 on November 4, 1975, authorizes the Board of Supervisors, by  
9 resolution, to designate sales areas where any street artist or  
10 craftsman previously certified may sell art or craft items;  
11 and

12 WHEREAS, A survey by the Art Commission found that in recent  
13 years more street artist spaces in the Downtown area had been  
14 eliminated due to construction, curb zone changes, newsracks,  
15 planter boxes, etc.; and

16 WHEREAS, The holiday season is the street artists' busiest  
17 selling period; and

18 WHEREAS, Last year and the previous seventeen years the Board  
19 of Supervisors in Resolutions Nos. 1024-99, 923-98, 993-97, 102396,  
20 922-95, 945-94, 875-93, 994-92, 926-92, 981-91, 863-90, 86089,  
21 838-88, 1030-87, 935-86, 935-85, 816-84, 960-83, and 916-82 approved  
22 temporary selling spaces for the street artists for the winter  
23 holiday selling season; and

24 WHEREAS, The Board of Supervisors in Resolutions Nos. 1024-  
25 99, 923-98, 993-97, 1023-96, 922-95, and 1003-92 approved

1 temporary selling spaces for street artists at Harvey Milk  
2 Plaza; and

3 WHEREAS, The Art Commission, after conducting a public  
4 hearing, recommends the renewal of the previous year's temporary  
5 sales spaces in the Downtown area and recommends the renewal  
6 of the previous year's temporary sales spaces at Harvey Milk  
7 Plaza; now, therefore, be it

8 RESOLVED, That the Board of Supervisors hereby designates  
9 the following temporary selling spaces for street artists  
10 certified by the Art Commission, for the winter holiday season  
11 of 2000 beginning on November 15, 1999 and ending on January  
12 15, 2001:

13 Spaces

14 12 - Market Street, south side, 4th to 5th Streets

15 5 - Market Street, north side, Montgomery to Kearny Streets

16 2 - Market Street, north side, Grant to Kearny Streets

17 10 - Market Street, north side, Battery to Sansome Streets

18 5 - Stockton Street, west side, Post to Sutter Streets

19 1 - Stockton Street, east side, Post to Sutter Streets

20 6 - Stockton Street, east side, O'Farrell to Geary Streets

21 3 - Stockton Street, east side, Market to O'Farrell Streets

22 2 - Montgomery Street, west side, Post to Sutter Streets

23 2 - Post Street, north side, Montgomery to Kearny Streets

24 1 - Post Street, south side, Grant to Kearny Streets

25 5 - California Street, north side, Sansome to Montgomery

7                   FURTHER RESOLVED, That the five (5) temporary spaces on  
8 Stockton Street, west side, Post to Sutter Streets, are exempt  
9 from the provisions of Police Code Section 2405(c)(8)(1) which  
10 prohibits street artists from selling, offering for sale or  
11 soliciting offers to purchase on any sidewalk adjacent to a  
12 curb which has been designated as a white zone; and be it

13                   FURTHER RESOLVED, That the one (1) temporary space on  
14 Stockton Street, east side, Post to Sutter Streets, is exempt  
15 from the provision of Police Code Section 2405(c)(8)(1); and  
16 be it

17                   FURTHER RESOLVED, That the one (1) temporary space on  
18 Post Street, south side, Grant to Kearny Streets, is exempt  
19 from the provision of Police Code Section 2405(c)(8)(1); and  
20 be it

21                   FURTHER RESOLVED, That one (1) of the five (5) temporary  
22 spaces on Stockton Street, west side, Post to Sutter Streets,  
23 is exempt from the provision of Police Code Section 2405(c)(6)  
24 which prohibits artists from selling, offering for sale or  
25 soliciting offers to purchase on any sidewalk within twelve

SUPERVISOR TENG

1 (12) feet from the outer edge of any entrance to any building  
2 including, but not limited to, doors, driveways, emergency exits  
3 measured in each direction parallel to the building line and  
4 thence at a 90-degree angle to the curb; and be it

5 FURTHER RESOLVED, That the two (2) temporary spaces on  
6 Post Street, north side, Montgomery to Kearny Streets, are exempt  
7 from the provisions of Police Code Section 2405(c)(6) and  
8 2405(c)(8)(3) which prohibits artists from selling, offering  
9 for sale, or soliciting offers to purchase on any sidewalk  
10 adjacent to a curb which has been designated a yellow zone;  
11 and be it

12 FURTHER RESOLVED, That the two temporary spaces on  
13 Montgomery Street, west side, Post to Sutter Streets, are exempt  
14 from the provisions of Police Code Section 2405(c)(6),  
15 2405(c)(8)(3), and 2405(c)(16) which requires street artists  
16 to engage in their activities in such a manner that at all times  
17 there shall remain open for the passage of pedestrians a space  
18 of at least ten (10) feet in width, as measured on a line  
19 perpendicular to the curb line, between the edge of the sidewalk  
20 farthest from the curb and the edge of the street artists'  
21 activities; and be it

22 FURTHER RESOLVED, That two (2) of the three (3) temporary  
23 spaces on Stockton Street, east side, Market to O'Farrell  
24 Streets, are exempt from the provision of Police Code Section  
25 2405(c)(6); and be it

1           FURTHER RESOLVED, That five (5) of the twelve (12) temporary  
2 spaces    on Market Street, south side, 4th to 5th Streets, are  
3 exempt from the provision of Police Code Section 2405(c)(6);  
4 and be it

5           FURTHER RESOLVED, That the four (4) spaces in the lower  
6 level of Harvey Milk Plaza are exempt from the provision of  
7 Police Code Section 2405(c)(6).


