7 WHEREAS, Section 7056 of the California Revenue and Taxation Code allows the  
8 governing body of a city and county by resolution to authorize designated officers and  
9 employees to examine confidential sales or transaction and use tax records of the State  
10 Board of Equalization; now, therefore, be it

11 RESOLVED, That the following officers and employees of the City and County of San  
12 Francisco, or other officers or employees of the City and County designated in writing by any  
13 one of the officers or employees listed below, are authorized to examine sales or transaction  
14 and use tax records of the State Board of Equalization:

- 15 -- Treasurer/Tax Collector
- 16 -- Tax Administrator
- 17 -- Director, Business Tax Division
- 18 -- Director, Bureau of Delinquent Revenue; and be it

19 FURTHER RESOLVED, That information obtained by examination of said State Board  
20 of Equalization records shall be used only for purposes related to the collection of City and  
21 County sales or transaction and use taxes, and for other governmental functions of the City  
22 and County of San Francisco; and be it

23 FURTHER RESOLVED, That this resolution shall supersede Resolution No. 269-94;




