

1 [Authorizing consulting firm to examine confidential State Board of Equalization tax records on
2 behalf of the Tax Collector.]

3 **Resolution authorizing Hinderliter, De Llamas and Associates to examine sales or**
4 **transaction and use tax records of the State Board of Equalization on behalf of the City**
5 **and County of San Francisco pursuant to California Revenue and Taxation Code**
6 **Section 7056.**

8 WHEREAS, The City and County of San Francisco has entered into a contract with the
9 firm of Hinderliter, de Llamas and Associates to perform audit and consulting services; and,

10 WHEREAS, Section 7056 of the California Revenue and Taxation Code allows the
11 governing body of a city and county by resolution to authorize persons other than officers and
12 employees to examine confidential sales or transaction and use tax records of the State
13 Board of Equalization on behalf of the City and County, subject to certain conditions; now,
14 therefore, be it

15 RESOLVED, That the City and County of San Francisco certifies that Hinderliter, de
16 Llamas and Associates: (1) has an existing contract with the City and County to examine
17 those sales or transaction and use tax records; (2) is required by that contract to disclose
18 information contained in, or derived from, those sales or transaction and use tax records only
19 to an officer or employee of the City and County who is authorized under Section 7056 of the
20 California Revenue and Taxation Code to examine the information; (3) is prohibited by that
21 contract from performing consulting services for a retailer during the term of that contract; and,
22 (4) is prohibited by that contract from retaining the information contained in, or derived from,
23 those sales or transaction and use tax records after the contract has expires; and be it




