

1 [Parking Regulations]

2 ENACTING AND RESCINDING PARKING REGULATIONS AT VARIOUS LOCATIONS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
4 and the San Francisco Traffic Code, the following regulations governing the parking of
5 vehicles are hereby enacted or rescinded as designated below:

6 **NO PARKING ANYTIME - ESTABLISH**

7 Acton Street, north side, from Mission Street to 80 feet easterly (80-foot zone)

8 Whittier Street, north side, from Mission Street to 80 feet easterly (80-foot zone)

9 Addison Street, east side, from Digby Street to 47 feet southerly (47-foot zone,
10 within traffic circle)

11 Houston Street, west terminus, west of Columbus Avenue (at the base of the
stairway leading to Jones Street)

12 **NO PARKING ANYTIME - RESCIND**

13 Alemany Boulevard, east side, from Foote Avenue to 40 feet southerly (40-foot zone)

14 Alemany Boulevard, west side, from Foote Avenue to 40 feet northerly (40-foot zone)

15 **RESIDENTIAL PERMIT PARKING AREA "P" (2-HOUR TIME LIMIT, 8 AM - 6 PM,
16 MONDAY THROUGH FRIDAY) - ESTABLISH**

17 McAllister Street, both sides, between Baker and Lyon Streets (1800 block)

18 **UNMETERED MOTORCYCLE PARKING - ESTABLISH**

19 London Street, east side, from 13 feet to 23.5 feet south of the north property line
of #335-#337 London Street (10.5-foot zone, between north and south
20 driveways, accommodating 3 motorcycles)

21 Pine Street, north side, from 67 feet to 77.5 feet west of Franklin Street (10.5-foot
zone accommodating 3 motorcycles)

22 Ritch Street, west side, from 25 feet to 35.5 feet south of the north property line of
#230-#236 Ritch Street (10.5-foot zone, between north and south driveways,
23 accommodating 3 motorcycles)

24 Taylor Street, east side, from driveway for #1328 Taylor Street to 7 feet southerly
25 (7-foot zone between driveways, accommodating 2 motorcycles)




