7 WHEREAS, the escalating rents in the San Francisco real estate market
8 have created hardships for non-profit organizations, individual artists, and arts
9 organizations, forcing many of them to move out of San Francisco; and,

10 WHEREAS, a permanent solution for the space crisis facing non-profit
11 organizations, individual artists, and arts organizations would be for the City and
12 County of San Francisco to purchase buildings for the purpose of creating
13 permanent space for them; and,

14 WHEREAS, in the current real estate market all buildings in San
15 Francisco are now in high demand and the City and County of San Francisco
16 needs to be able to respond quickly to opportunities to purchase buildings; be it,

17 RESOLVED, the Board of Supervisors of the City and County of San
18 Francisco urges the San Francisco Department of Real Estate and the San
19 Francisco Redevelopment Agency to maintain a database of underutilized
20 buildings and buildings for sale, totaling up to 300,000 square feet, that could be
21 purchased by the City and County of San Francisco to be used for non-profit
22 organizations, artist work space and artist performance space.




