2 URGING THE SAN FRANCISCO CITY ATTORNEY'S OFFICE TO FILE AN AMICUS  
3 LETTER WITH THE UNITED STATES DISTRICT COURT IN SAN FRANCISCO URGING  
4 THE COURT TO DENY PG&E'S REQUEST TO RAISE CONSUMER ENERGY BILLS \$3.4  
5 BILLION DOLLARS.

7 WHEREAS, California's deregulation plan (AB 1890) specifically requires utility rates to  
8 be frozen for a period of time before rising to market levels, and does not allow the utilities to  
9 recover additional charges after the rate freeze to make up for alleged shortfalls in revenue  
10 during the rate freeze period; and,

11 WHEREAS, PG&E has requested a rate hike in order to recoup a reported loss of  
12 more than \$3 billion; and,

13 WHEREAS, The California Public Utilities Commission (CPUC) has held that no costs  
14 incurred during the rate freeze can be carried forward into the post rate freeze period; and,

15 WHEREAS, PG&E has asked the United States District Court in San Francisco to  
16 grant it permission to raise consumer energy bills \$3.4 billion dollars; and,

17 WHEREAS, Allowing PG&E to recover losses incurred under the rate freeze would be  
18 financially detrimental to PG&E's customers; now, therefore, be it

19 RESOLVED, That the Board of Supervisors of the City and County of San Francisco  
20 urges the San Francisco City Attorney's Office to file an amicus letter with the United States  
21 District Court in San Francisco urging the Court to deny PG&E's request to raise consumer  
22 energy bills \$3.4 billion dollars.


