1 REQUESTING THE METROPOLITAN TRANSPORTATION COMMISSION (MTC) TO  
 2 INCLUDE IN ITS WORK PLAN A METHOD PROVIDING FOR 24-HOUR BART SERVICE  
 3 BETWEEN THE NORTHERN PENINSULA, SAN FRANCISCO AND THE EAST BAY TO MEET  
 4 THE CURRENT AND PROJECTED NEEDS OF SPECIFIC DEMOGRAPHIC GROUPS; AND  
 5 REQUESTING MTC TO CONSIDER RAIL AND BUS AS ALTERNATIVE MODES OF  
 6 TRANSPORTATION; REQUESTING MTC STAFF TO WORK WITH ALL APPROPRIATE LOCAL  
 7 AND REGIONAL TRANSPORTATION AGENCIES TO PRODUCE A WORKABLE PLAN TO BE  
 8 PRESENTED IN DRAFT FORM TO THE MTC BOARD NOT LATER THAN SIX MONTHS FROM  
 9 THE DATE OF THIS RESOLUTION

10 WHEREAS, Demographic and economic changes in the Bay Area, particularly housing  
 11 costs, have resulted in people moving to the East Bay and down the Peninsula; and,

12 WHEREAS, The needs of recent welfare-to-work individuals now in the workplace have  
 13 created the necessity for speedy late-night transportation service between the northern Peninsula,  
 14 through San Francisco, and to the East Bay; and

15 WHEREAS, In addition to these two groups, there is increased need for late night service  
 16 among:

- 17 ■ Night workers, such as service-sector employees: restaurant workers, hotel  
 18 employees, office cleaning staff; late-night employees at San Francisco International  
 19 Airport, including maintenance crews and facilities people; and  
 20 those who occasionally or regularly must work past midnight
- 21 ■ Airline passengers who come in after midnight
- 22 ■ People who cross the Bay or come up from the Peninsula for entertainment at night;  
 23 and

24 WHEREAS, Connecting service between existing county-based transportation systems  
 25 creates a confusing journey for the occasional rider and a time-consuming journey for everyone,  
 even under the best conditions; now, therefore, be it

1 RESOLVED, That MTC is requested to include in its work plan a method providing for 24-  
2 hour BART service between the Northern Peninsula, San Francisco and the East Bay to meet the  
3 current and projected needs of the demographic groups described above; and, be it

4 FURTHER RESOLVED, That MTC is requested to consider rail and bus as alternative  
5 modes of transportation; and be it

6 FURTHER RESOLVED, That MTC staff is requested to work with all appropriate local  
7 and regional transportation agencies to produce a workable plan to be presented in draft form to  
8 the MTC Board not later than six months from the date of this resolution.




