2 RESOLUTION DETERMINING THAT THE ISSUANCE OF A TYPE 48 ON-SALE  
3 GENERAL PUBLIC PREMISES LIQUOR LICENSE IN EXCHANGE FOR A TYPE 47  
4 ON-SALE GENERAL EATING PLACE LIQUOR LICENSE TO GREG LINDGREN AND  
5 JON GASPARINI, FOR THE ALPS HOTEL CORPORATION (“DES ALPS”) LOCATED  
6 AT 730-732 BROADWAY, WILL SERVE THE PUBLIC CONVENIENCE AND  
7 NECESSITY OF THE PEOPLE OF THE CITY AND COUNTY OF SAN FRANCISCO,  
8 IN ACCORDANCE WITH SECTION 23958.4 OF THE CALIFORNIA BUSINESS AND  
9 PROFESSIONS CODE; WITH CONDITIONS.

11 WHEREAS, Greg Lindgren and Jon Gasparini are seeking issuance of a Type  
12 48 on-sale general public premises liquor license in exchange for a Type 47 on-sale  
13 general eating place liquor license for the Alps Hotel Corporation (“Des Alps”), located  
14 at 730-732 Broadway; and,

15 WHEREAS, The City Planning Department has verified that the area is properly  
16 zoned; and

17 WHEREAS, The Police Department recommends that the liquor license  
18 application be approved with conditions; now, therefore, be it

19 RESOLVED, That in accordance with Section 23958.4 of the California Business  
20 and Professions Code, the Board of Supervisors of the City and County of San  
21 Francisco hereby determines for the foregoing reasons that the issuance of a Type 48  
22 on-sale general public premises liquor license in exchange for a Type 47 on-sale  
23 general eating place liquor license, to Greg Lindgren and Jon Gasparini for the Alps  
24 Hotel Corporation (“Des Alps”), located at 730-732 Broadway will serve the public  
25 convenience and necessity of the people of the City and County of San Francisco.

1           Conditions: 1) Sales, service and consumption of alcoholic beverages shall be  
2 permitted only between the hours of 11:00 AM and 2:00 AM each day of the week. 2)  
3 The petitioner shall be responsible for maintaining free of litter the area in front of and  
4 adjacent to the premises over which they have control.




