2 **EXTENDING THE OPERATING DATE OF THE POTRERO POWER PLANT**
3 **CITIZENS ADVISORY TASK FORCE TO OCTOBER 31, 2001.**

4 Whereas, By Resolution 362-99 The Board of Supervisors
5 created a Potrero Power Plant Citizens Advisory Task Force
6 to provide input to the City & County of San Francisco
7 regarding the sale, operation and maintenance of the Potrero
8 Power Plant, and to complete its work by December 31, 2000,
9 and

10 Whereas, the Task Force was formed in response to the
11 concern of San Francisco residents that the closure of the
12 Bay View Power Plant and sale of the Potrero Power Plant may
13 result in the Potrero Power Plant operating at a higher
14 capacity, and thereby emitting higher levels of pollution
15 and noise than earlier, and

16 Whereas, the Task Force has not completed its analyses
17 of the impacts of the sale and continued operation of the
18 existing Potrero Power Plant on the surrounding neighborhood
19 and desires additional time to do so, and

20 Whereas, the Southern Company has filed an application
21 with the California Energy Commission for certification of
22 anew 540 MW generating facility at the Potrero Power Plant
23 site, and

24 Whereas, the City and County of San Francisco will
25 participate in the California Energy Commission proceeding
regarding this application and the City desires the input of

1 the Task Force regarding issues arising from this proposal
2 which may adversely affect the surrounding neighborhood;
3 now, therefore, be it

4 Resolved, That the City and County of San Francisco
5 extends the operating date of the Potrero Power Plant
6 Citizens Advisory Task Force to October 31, 2001.
