10 32 years as a member of the San Francisco Police Department, retiring at the rank of  
11 Captain; and

12 WHEREAS, The San Francisco Police Credit Union, founded 1953 with 15 members  
13 has continued to grow and expand to become one of the outstanding California Credit Unions  
14 within its peer group with over 18,000 members; and,

15 WHEREAS, Thomas G. Dempsey was one of the early members of the San Francisco  
16 Police Credit Union and dedicated much of his time to nurture the growth of the San  
17 Francisco Police Credit Union during his career and after his retirement; and,

18 WHEREAS, Thomas G. Dempsey, during his volunteer service to the San Francisco  
19 Police Credit Union, served in virtually every volunteer capacity and on every Credit Union  
20 committee including the Board of Directors; and,

21 WHEREAS, During the period that Thomas G. Dempsey was Chair of the Credit Union  
22 Building Committee, the San Francisco Police Credit Union completed the largest expansion  
23 in its history, relocating its offices to 2550 Irving Street becoming a distinguished member of  
24 the business community in the Sunset District; and,


