17 sale general alcoholic beverage control license from 2935 24<sup>th</sup> Street to 1400 Ocean  
18 Avenue for Khim Lim for Tay Hour Market, determining that it will not serve the public  
19 convenience and necessity of the people of the City and County of San Francisco.


