Resolution urging the Department of Parking and Traffic to work with the Department of Public Works, the Planning Department and the Redevelopment Agency to study, and develop a proposal regarding, the establishment of striped bicycle lanes on Seventh Street in San Francisco, between 16th Street and Townsend, and to ensure that such proposal would not conflict with the Mission Bay Redevelopment Plans and related Mission Bay project agreements approved by the City.

WHEREAS, The City wishes to promote bicycle safety and encourage bicycle commuting as an alternative mode of travel to help reduce traffic congestion in the City; and

WHEREAS, The Board of Supervisors supports environmentally cleaner modes of transportation, like bicycle riding; and,

WHEREAS, By creating striped bicycle lanes on 7th Street, between 16th Street and Townsend, the City would facilitate increased safety for bicyclists in the Mission Bay area who commute on 7th Street; now, therefore, be it

RESOLVED, That the Board of Supervisors urges the Department of Parking and Traffic to work with the Department of Public Works, the Planning Department and the Redevelopment Agency to study, and develop a proposal regarding, the establishment of striped bicycle lanes on Seventh Street in San Francisco, between 16th Street and Townsend, and to ensure that such proposal would not conflict with the Mission Bay Redevelopment Plans and related Mission Bay project agreements approved by the City.


