20 to, as Chair of the Public Health and Environment Committee, Vice Chair of the Finance and  
21 Labor Committee, and as a Member of the Housing and Social Policy Committee; now,  
22 therefore, be it

23 RESOLVED, That the members of the Board of Supervisors, on behalf of the officers,  
24 employees and citizens of this City, do hereby take public recognition of the distinguished  
25 contributions which Supervisor Sue Bierman has made to the welfare of this community, and

1 do express to her their appreciation for her high quality work, their thanks for her presence,  
2 and their hopes for the best in her future endeavors; and, be it

3 FURTHER RESOLVED, That a framed copy of this resolution be tendered to  
4 Supervisor Sue Bierman as a token of the great affection and respect in which she is held by


