14 Committees, including, but not limited to, serving as Chair, Parks and Recreation Committee,
15 and Vice Chair, Public Health and Environment Committee; and,

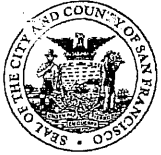
16 WHEREAS, Supervisor Brown addressed issues related to the support of quality of

21 Minority Business Enterprise/Women Business Enterprise/Local Business Enterprise
22 (MBE/WBE/LBE) ordinance to address identified discrimination of prime contractors; now,

25 employees, and citizens of this City, do hereby take public recognition of the distinguished

1 contributions which Supervisor Amos Brown has made to the welfare of this community, and

3 and their hopes for the best in his future endeavors; and, be it




