2 ENACTING AND RESCINDING TRAFFIC REGULATIONS ON VARIOUS STREETS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code
4 and the San Francisco Traffic Code, the following regulations governing the movement of
5 vehicles are hereby enacted or rescinded as designated below:

7 3rd Street, west side, from Kirkwood Avenue to 35 feet northerly

8 3rd Street, west side, from Kirkwood Avenue to 85 feet southerly




